

# HERITAGE EXPRESS RIDES AGAIN

The fifth running of the Heritage Express took place on April 25 and 26 from Carbondale to Steamtown National Historic Site in Scranton. Fourth grade students from Lackawanna Trail, Blue Ridge, Waverly, Bancroft, Forest City, Fell Township, and Carbondale boarded the Heritage Express train for a day-long education experience through the Lackawanna Valley. Each class was introduced to the program by a Steamtown ranger who visited their school before the excursion and distributed curriculum guides from local museums that teachers could use for follow up activities after the trip. This year's excursion welcomed two special guests, Mr. Bernie O'Brien, former Delaware and Hudson Engineer with more than 50 years experience, and Mr. Flood, retired Erie Railroad Engineer. Both men captivated the students as they shared some of their favorite railroad stories. Thanks to all of the volunteers who helped make this event a success and special thanks to the Lackawanna Heritage Valley Authority for its continued support of this project.

#### **Folk Art Lecture Series**

The Lackawanna Historical Society's Early American Culture and Folk Art Lecture Series was completed on May 5th with the final lecture focusing on the theme of Patriotism. Twenty-two people attended the series to listen to Josephine Dunn, Ph.D. speak on folk art and its relation to American society. Dr. Dunn's illustrated lectures used local and nation works of art to discuss the themes of patriotism, education of women, mourning, rituals, portraiture, and landscapes. In April, she guided the participants in a hands-on workshop to create therom paintings, which are currently on display at the Catlin House. We are grateful to Dr. Dunn for sharing her time and knowledge for this series and to the Pennsylvania Council on the Arts, Pennsylvania Partner in the Arts, and the Scranton Area Foundation for sponsoring this popular program.

This Summer, the Lackawanna Historical Society will join forces with Steamtown National Historical Site by providing tours of the Catlin House to Steamtown short excursion passengers. This will give Steamtown an opportunity to provide their visitors with a more complete story of how Scranton's industrialists lived at the turn-of-the-century.

#### **Educational Programs at the Catlin House**

In the last few years, the Lackawanna Historical Society has taken an active lead in educational programming. Two very exciting programs are worth mentioning. The Museums as a Classroom program continued this year, after great success in 2001. The program, which is offered to local teachers through the Northeast Educational Intermediate Unit #19, gives participants an opportunity to learn about Lackawanna Valley historical sites and the resources available for enhancing classroom instruction. This spring, 22 teachers visited the Catlin House, Steamtown National Historic Site, the Lackawanna County Trolley Museum, the Anthracite Heritage Museum, and the Everhart Museum. In addition the Society conducted a downtown walking tour to familiarize the group with some of Scranton's architectural treasures. The program will be offered again this summer with 40 participants.

A second program that the Society has initiated at the Catlin House is Student Curators at Work. This project was created as a way for the Society to participate in the Scranton School District's Best Program which is an after-school program that gives students an opportunity interact and learn about some of the city's cultural institutions. Eight students from Northeast Scranton Intermediate have been meeting at the Catlin House every Tuesday and Thursday after school to plan an exhibit on the strike of 1902. The students toured the Anthracite Museum and the Catlin House and attended short lectures by local museum professionals to learn more about the Anthracite Industry and Exhibit Design before they began to plan their exhibit. The exhibit is scheduled to open at the William Nealon Federal Building in downtown Scranton on May 23rd. Participating students are Nathan Stebbins, Dylan Cawley, Lauren Mursch, Carolyn Horlacher, Renae Fisher, Krista Somers, Charles Fisher, and Nick Miller.

#### LHS Volunteer Discovers Treasure in her Back Yard

Yellowood student and LHS volunteer Kristen Fratzola has been working at the Catlin House since February. Recently while assisting staff in a small research project, Kristen discovered a postcard of Luna Park in Jack Hiddlestone's "Wish You Were Here...A Picture Postcard History of Lackawanna County, Pa" She was intrigued because she had never heard of it before and it was located not far from her house. Kristen decided to investigate this new discovery using the Catlin House resources, talking to her grandfather, and interviewing Jack Hiddlestone. This is her story:

When I first asked my grandfather about Luna Park, he told me that he remembered a little bit. He said that there used to be a entrance that ran over to the park from the back of the CMC parking lot, where the helicopter's landing is located. He remembered walking there with his grandfather all the way from Tripp's Park and that it was only a nickel to get in. This interview sparked an even stronger interest so I asked the staff if I could learn more from the LHS records.

After reading a copy of "Scranton Luna Park" by Jack Hiddlestone, I learned that the Luna Park opened on May 28, 1906 at the cost of \$3,000,000. It was created by Fredrick Ingersoll of Pittsburgh. The 20 acre park was located across Roaring Brook from the old Nay Aug Zoo. There were two entrances, one at Nay Aug across a foot bridge over Roaring Brook and the DL&W tracks, the other on the opposite side of the park just beyond the Laurel Line tunnel. The admission fee was ten cents for adults and a nickel for children.

The park was operated as a family resort where women and children could walk around feeling as



protected as they would in their own homes. There were also many other Luna Parks around the country including Cleveland, Ohio; Pittsburgh, Pa; and Coney Island, New York.

There were 30 different attractions in the park including picnicking areas, a dance hall, restaurants, and the lake. Some of the rides included:

- \* The Scenic Railway, one of the largest constructed, running over 1/2 mile through the prettiest section of Luna.
- \* The Aerial Swings, a steel framed tower that swung large boat shaped cars out over a 45 degree angle, also known as the "circle swing."
- \* The Merry-Go-Round, which was said to be one of the largest of its time, built at the reported cost of \$10,000.
- \* Blarney Castle, where startling things were found with endless dark passages, gusts of winds, flip-flop floors and other odd wonders.
- \* The Dance Hall, which held up to 3,000 people at a time. The dance floor was 60 x 140 feet. Underneath the pavilion could also be found the fish pond, a knife rack, cane rack, and other attractions.
- Finally, the most popular ride of them all was Shoot-the-Chute. The tower of this marvelous ride was 85 feet high and inclined into a pool 350 feet long. The fully concreted lagoon was 90 feet wide and 300 feet long. Each boat would be drawn up one chute of the ramp to the top, which then turned around plunging the rider into the lagoon like an arrow.

On Wednesday morning on Aug. 23, 1916, at 3:00 a.m. Luna Park caught fire. How the fire was started was unknown but some stockholders said that it was possible a spark from either an Erie or a Lackawanna engine, which runs nearby, ignited the once lovely park. The flames quickly spread from the Dance Hall, across the wooden bridge to the coaster station and then to the Chutes. It was 6 a.m. before the fire was considered under control.

The insurance to the park had ran out several months prior to the fire and was never restored. However, owners of the park were able to rebuild a temporary dance floor and the roller coaster station within weeks hoping to catch some end of the season business. A few weeks later Mr. Victor Graybill, the park manager, tried to bring back crowds by advertising a free admission day. But little did the customers know that they still had to pay an

initial entrance fee of 10 cents. Hundreds of people paid but once in the park, they broke into rage and rioting ensued. The damage was beyond repair and Scranton's Luna Park never reopened.

In 1917 the park equipment was auctioned off and the city of Scranton took over ownership. Today, almost 86 years later, Interstate 81 runs through the center of the old park. The only remains left of Luna Park today, as we know from Jack Hiddlestone, are the corner of the lagoon, the concrete subway from the Laurel Line station, and even the take off point at each end of the long gone bridge from Nay Aug.

After learning its history, I decided to explore the actual site myself. Since my grandfather told me that it was behind the CMC parking lot, I began there. Not realizing where I was going, I found myself walking on trails behind the old Nay Aug Zoo. After climbing down slopes of rocks I finally found something. There were several foundations, one was a stone wall that seemed to run in a circle ("Was this the lagoon?" I wondered), some sort of concrete structure that resembled part of a bridge (I thought this was the old foot bridge), and lastly an old tunnel (possibly the old subway that ran into Luna). After seeing all of this, I decided to return with a camera and take some pictures. The next day at the Catlin House, I tried to figure out what it was that I had found. After about two hours of looking, I realized that it was not Luna Park that I had found, but an old Toll House and Toll Bridge or so it seemed.

I was sure I would never find this on my own, so I looked in a 1918 map of the area. It turns out I was on the wrong side of the tunnel! Still quite confused, I called

Jack Hiddlestone to find out more about the location. Jack was able to give me more precise directions and I was off on my expedition again.



That day, after school, I drove to the other side of the tunnels. Walking along the tracks that I had identified from the maps, I knew I was in the right area. I just wasn't looking hard enough. At this point, it hit me. I'd been looking on my right side, so I turned to my left. Within the next 10 minutes I had found the old lagoon and foot bridge! It was hard to believe that once, on this very same spot, had been one of the city's most popular parks.

I am glad I had the opportunity to discover this hidden treasure, virtually in my own backyard, and I hope to continue to learn more about my neighborhood as I continue my work at the Catlin House.
