Milestones: Highlights From Dunmore's History

Dunmore was founded in 1862, during the second year of the Civil War, when Governor Andrew G. Curtin signed a bill making Dunmore an official borough. The borough, at the time in Luzerne

County, had grown during the previous 80 years.

The first settler in Dunmore arrived in 1783. He was William Allsworth, a shoemaker who followed the Connecticut-Cobb Road (present-day Drinker Street) and settled at the "Corners." Allsworth erected a log cabin and an inn that was frequented by settlers moving westward. In a few short years Allsworth had several neighbors, and the growing settlement began to be called Bucktown because of the great abundance of deer in the surrounding woods.

Dunmore earned its present name in the 1830s when Henry Drinker, a local landowner, enticed Sir Charles Augustus Murray to fund development in the Lackawanna Valley. Sir Charles was the son of the Earl of Dunmore, and Drinker convinced the settlers to change the name of Bucktown to Dunmore to honor the earl out of gratitude. Despite the fact that Sir Charles never managed to raise the money Drinker had asked for, the name Dunmore stuck to the settlement. It is unlikely that Sir Charles ever set foot in the village that bears his name

The first major event of note in Dunmore was the completion of the Philadelphia and Great Bend Turnpike in 1826. The turnpike ran through the town and was built with the backing of Henry Drinker. Drinker tried on several other occasions to bring development to the town by proposing railroads and canals that made a stop in Dunmore, but he was never successful.

For more than 75 years, the main industry in the borough was mining by the Pennsylvania Coal Company. In 1849, a gravity railroad was built, and in 1850 the first coal was taken from three veins in the borough. The first shaft was sunk in 1855, and the town had

three more shafts as well as two breakers by 1888.

The first newspaper in the town was the *Dunmore Pioneer*, which was first printed in 1886. In 1889 fire

destroyed the paper's publication office, and the owner made no attempt the revitalize the paper. In 1912 a Scranton printer founded *The Dunmorean*, a paper that continues to service the borough today.

Dunmore holds several large cemeteries with the largest being the 35-acre Dunmore Cemetery. This cemetery

began in 1828 when a local landowner donated one acre to serve as a burial ground. It is believed Gabriel Dunning was the first person to be buried there.

Education started in the borough in 1826 when the first school, which also served as the local church, was built. The school system was formalized in 1868 when the "old brick" high school was built to replace four smaller, poorly supplied school houses. The school boasted a staff of seven teachers who made monthly salaries of \$52 for men and \$28 for women. In 1902 Dr. Charles F. Hoban was named the superintendent of the Dunmore School System.

Under Dr. Hoban's guidance, the schools of Dunmore were promoted into the most esteemed circles of education in the Commonwealth. The current Dunmore High School was built in 1937 because of overflow from Scranton Central High School.

Marywood College was established in 1915 as an all-girls school. For many years it was considered to be the premier institution of higher learning for women in the Commonwealth. In 1964 the college became coeducational and still maintains a reputation for academic excellence.



AMENDMENTS TO THE BY-LAWS OF THE LACKAWANNA HISTORICAL SOCIETY

The following changes to the By-Laws of the Lackawanna Historical Society were approved by the LHS Membership at the December 9th, 2010, Members-Only Holiday Open House.

Article III § 2: Membership:

Article IV: § 1: Officers

Current: The Officers of the Society shall be President, two Vice-Presidents, a Secretary, a Treasurer and an Assistant Treasurer, to be elected annually by the Society.

Change: The Officers of the Society shall be President, two (2) Vice-Presidents, a Secretary, a Treasurer and an Assistant Treasurer, to be elected annually by the Board of Trustees at their January meeting, or the first meeting of the Board of the new year.

Article IV: § 4: Officers

Current: All Officers shall serve without salary.

Change: All Officers shall be members of the Board of Trustees, and shall serve without salary.

Article V: § 1: Board of Trustees

Current: The Board of Trustees shall consist of no less then fifteen active members of the Society, one third of whom shall be elected annually for a three year term by the Society. Trustees will be eligible for three 3-year terms at the discretion of the Board and determined by availability of Board Members.

Change: The Board of Trustees shall consist of no less then fifteen (15) active members of the Society, one third of whom shall be elected annually for a three (3) year term by the Society. {Trustees will be eligible for three 3-year terms at the discretion of the Board and determined by availability of Board Members.}*

Article V: § 3: Board of Trustees

Current: In addition to those elected as above provided, the election of officers shall also serve as members of the Board of Trustees.

Change: Eliminate section - conflicts with changes to Article IV, § 4 above.

Article V: § 4: Board of Trustees

Current: The President of the Society shall preside at meetings of the Board of Trustees.

Change: The President of the Society shall preside at meetings of the Board of Trustees, or one of the Vice-Presidents in the absence of the President. In the event a quorum of the Board of Trustees is established and the President and Vice-Presidents are absent, a majority of the members of the Board present shall select one of their members to chair the meeting.

Article VII: § 1: Meetings

Current: An annual meeting of the Society for the election of the Officers and Trustees and for the transaction of such other business as may be necessary shall be held in November, or at such other time as the Board of Trustees may direct.

Change: An annual meeting of the Society for the election of the Board of Trustees and for the transaction of such other business as may be necessary, and shall be held in December, or at such other time as the Board of Trustees may direct.

Additional proposed clauses:

Tax Exempt Statement

This Society is organized exclusively for charitable and education purposes as such purposes are defined by § 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Internal Revenue Law of the United States). No part of the net earnings of the corporation shall inure to the benefit of any individual and no member, director, officer or employee of the Corporation shall receive any pecuniary benefits of any kind except reasonable compensation for services in effecting the corporate purposes. No substantial part of the services of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, nor shall the Society participate or intervene in (including the publishing or distributing statements of) any political campaign on behalf of any candidate for public office.



A New Jersey Volunteer in Lackawanna County

Bob Morrisette has been a volunteer with the Lackawanna Historical Society for about four years. He and his wife Linda live in Paramus, NJ and started visiting when their son Paul was at the University of Scranton. Paul graduated in 1999. About eight years back, Bob stopped by Steamtown National Historic Site to check on a great-grandfather and grandfather who were both employed by the Lackawanna Railroad. He did not find his ancestors, but he did find a volunteer position cataloging railroad personnel records. During that time Bob met the people of the Society. When Bob completed the personnel records after 3 1/2 years, he asked about maps at the Lackawanna Historical Society and what he might do to make them accessible and documented. His offer was met with open arms.

Each month Bob drives over for three days, usually Tuesday morning to Thursday afternoon. During the summer Linda is off from teaching and also comes. Bob has made tremendous progress with initial organization and subsequent cataloging of the map collection. All is not work, though, as he has many friends and an active social calendar. We look forward to those monthly visits and appreciate the good work from our New Jersey connection. Bob sent this Christmas note to Mary Ann Moran-Savakinus, the director, and Ella Rayburn, volunteer curator:

Dear Mary Ann and Ella,

Ella and I spent so much time repairing our 1911 Lackawanna County Wagon Trail map this past visit, I was only able to catalog three additional maps. Therefore, instead of sending the usual "Update", I thought it might be fun to take just a few moments to review where we are with "the Project". With four years and 685 hours invested (that includes a vast amount of lunches and coffee breaks), we completed the preliminary "collections and sorting" portion of the project last December, 2009. In April of this year, I began to catalog and repair the maps and place them in folders. Over the past nine months, 58 documents have been cataloged, many repaired. At this rate I estimate, the project will be completed December, 2057. Linda and I plan to throw a party at our convalescent home at that time and everyone will be invited. Details to follow.

Other interesting statistics concerning my four year project:

- 1. Hours spent commuting between Paramus and Scranton: 156
- 2. Nights spent at the Lackawanna Radisson Hotel: 77
- 3. El Pepe Steaks consumed this past year: 5
- 4. Lions Club Magic Shows Attended: 1

I love this project, I enjoy my association with the Historical Society. I have reservations at the Radisson for February 1st through to the 3rd, 2011.
